Introduction – Who We Are & What We Do

Lawrence Interdenominational Nutrition Kitchen, Inc (LINK) was established on Valentine's Day, February 14, 1985, with a mission of providing healthy, home-cooked meals in a safe environment for the homeless, hungry, lonely, physically or mentally disabled, and low socioeconomic individuals at no cost to them. Diners are treated as guests and members of the LINK family. Thirty-six years later, this continues to be LINK's mission - to feed people regardless of their circumstances.

LINK is committed to improving the quality of life and honoring the dignity of those it serves when providing a hot meal to any member of our community who wants one.

Currently, LINK is supported by about 45 religious organizations, businesses, and civic groups which provide and serve the food, as well as many individuals who contribute to the organization. LINK is grateful for the support of the leaders and congregation of The First Christian Church, which allows LINK to use the church's basement as a kitchen & dining room for minimal rent.

LINK is a 501(c)(3) Not-for-Profit Corporation which operates out of the basement of the First Christian Church, 1000 Kentucky, Lawrence, KS 66044. LINK's dining room and kitchen can be accessed through the north basement door of the church, on 10th Street. LINK's employer identification number is 48-1071888.

President's Report

After taking on the role as Board President for LINK this past fiscal year, we set to the task of understanding the ramifications of the prior year as LINK tried to get "back in the saddle". Our pressing needs were to stabilize staff and payroll as well as improve operations. At about the same time, issues surrounding homeless peoples' behaviors caused strained relationships with FCC. Their concern was that LINK was a catalyst for trespassing, loitering, and property damage done by homeless people. So along with focusing on how to better implement the basics of LINK's mission, we also found ourself in a strained position with our landlord, something we've never experienced before. This has been a year that fits the description of "two steps forward, one step back". Yet, through the challenges, LINK has managed to power through, increase lunch service, and celebrate 40 years of providing lunch to anyone who comes through our serving line.

Steps forward:

- LINK has been fortunate to tap the input and talents of newer board members, namely, Kate Konie, Brennan Clark, Barbara Clinger, and Tom Ruddy. Our organization is stronger because of their enthusiasm, critical thinking, combined knowledge, and generous hearts.
- We finally have had the time to discover the depth of the need for managerial coordination at LINK and what that entails. By implementing oversight, asking questions, and input from board members and staff, LINK operations are on a smoother footing, recovering from the loss of Bonnie, and perhaps being guided by her.
- Personnel issues have settled with Calvin Barnes taking on the weekday prep and clean schedule, and Darrell Vann continuing with the weekend routine.
- LINK continues with enthusiasm for volunteering from community and churches, including the newest groups, the National Charity League and Worden Cornerstone Church.
- LINK met with a committee from FCC to discuss ways to minimize loitering by LINK guests. LINK implemented signage and worked with HRC to discourage loitering when LINK is not open. And conversations with people when they are on church grounds outside of serving hours.

Steps backward:

- LINK was blindsided when our lease with FCC was replaced with a "Users Agreement", and a 283% increase in monthly fees. LINK cooperated with FCC so they could make a plea to serving groups to pay "their fair share." Groups that have the ability to donate more have done what they can.
- Substantial grant funding dried up due to the federal government's DOGE dismantling of human service funds for FEMA.

The backward steps point in one direction: LINK must develop connections to get more donations for managerial operations and overhead costs with respect to rising costs and diminished grant funding.

Service:

As the data you will see in the rest of this report illustrates, meals served continue to rise. Still we ended the year strong financially in spite of the user's fee. Guided by our treasurer, Brennan Clark's understanding of our fiscal position, LINK approaches our finances with cautious optimism, knowing there is work ahead for 2025-2026. It's fair to say that this can be said for nearly all non-profit entities in the current socioeconomic climate.

And finally, February, 2025 marked <u>LINK's 40th anniversary of service</u>. LINK continues to serve hot, nutritious meals to anyone and everyone who shows up. This is inspirational.

I cannot thank our board members, staff, and volunteers enough for all of their work and other contributions to the LINK effort. I am grateful for the community that continues to embrace the LINK mission and enable us to have the privilege to honor our truest human nature with the basic, yet not so simple act, of serving lunch.

Daily Operations Report

This year LINK was in transition with respect to the Weekday Co-ordinator's position. Amy Carlson worked to organize LINK's operations and strengthen their staff. As a result LINK's board has had time to analyze our need for a manager's position.

The number of guests that we served during our 2023-24 fiscal year increased 11.5% over the prior year. This increase mostly came on in the 4th quarter of the year. This trend is expected to continue. LINK partnered with Just Food for food donations and on several occasions with volunteer groups to do cleanup and maintenance at LINK, and those who did kind gestures, like treat bags during the holidays and food drives. LINK also received a new gas range from Plymouth Congregational Church.

LINK Financial Report - July 1, 2024 – June 30, 2025

This has been a good year for LINK financially. Generous contributions from the Lawrence community increased 28% year-over-year. We were not able to secure grants as we have done in the past, but the increase in donations limited the sting of grants not received.

LINK's expenses decreased by 12% in FY 2024-25, with the largest decreases in operating expenses and payroll, primarily due to an active board taking on responsibilities that were performed by paid employees in years past. The Thanksgiving meal was down, which might just be a difference in how it was documented on the financial statement. However, food costs were also down overall, so it is likely that Thanksgiving expense was down for the year. Our volunteer groups provided most of the other food, and Corpus Christi Catholic Church graciously allowed us to use its facilities to assemble the meals with volunteers.

The cost per meal decreased 16% year over year while LINK served 5% more meals than last year. Since many of LINK's operating costs, such as rent and payroll, are fixed regardless of the number of meals served, the cost per should decrease as the number of meals goes up. The table below presents a history of LINK's cost per meal over the past decade.
